### WHO SHOULD APPLY?

Small to medium heritage organisations based in Scotland, England, Wales and Northern Ireland who:

- Have an income generating idea which is not yet fully formed
- Need the resources and support this programme offers to pursue this idea
- Will release up to two people from the organisation, ideally a trustee and a staff member, to participate
- Can commit to the full programme schedule
- Will contribute £50 per person per organisation to access all of the support

Receive a 14 month package of support to develop your income generating idea



Unlock up to £10,000 for your organisation to get your idea off the ground



Participate in a programme of online learning days and webinars



Connect in Heritage Café style gatherings to share experiences and learn from others

Attend a masterclass to explore alternative sources of finance



Apply your learning to develop your idea throughout the programme
